# **Position Summary**

The Metal Fabricator Programmer is responsible for programming, fabricating, and welding product

### **Essential Duties and Responsibilities:**

Essential functions include, but are not limited to the following:

- CNC Sheet Metal Programming for turret punch press (AMADA or Equivalent)
- Set-up and operating turret punch press (AMADA or Equivalent)
- Set-up and operation of press brake
- Welding (TIG Primarily)
- Deburring and parts finishing
- Hardware installation
- Raw material and hardware inventory maintenance
- In-process and Final Inspection
- Packaging

#### Minimum Qualifications (Knowledge, Skills, Abilities)

- Demonstrated competency in sheet metal CNC programming (Solid Works/ Merry Mech or similar)
- High School/Trade School Diploma or equivalent educational experience
- High Level of experience in blue print reading
- High level of experience using inspection equipment, examples: Micro Height, Calipers, Micrometers, Gage Pins, Radius Gages
- High attention to detail
- 3+ years of product inspection experience
- General understanding of Electro-Mechanical Assembly, Machining & Fabrication
- Working knowledge of Microsoft Office (i.e. Word, Excel, Outlook)
